- ❖ I/We understand that the information given is true and correct to the best of my knowledge and belief.
- ❖ I/We understand this permit is valid only for the work noted and expires 6 months from date of issuance.
- ❖ I/We understand that all demolition will be done in accordance with town and state regulations and that compliance is the sole responsibility of the applicant.
- ❖ I/We understand that the proposed work shall be done in accordance with the plans, sketch, and specification submitted. I/We further understand that no changes to the permit shall be made without written notification to the Town and that changes may result in the need for additional approvals.
- ❖ I/We understand that the demolition permit shall be posted so as to be visible from the street.
- ❖ I/We hereby agree the Fire Chief, Public Works Director, Water Superintendent, and Town Assessment Official have the authority to enter and inspect the premises.
- ❖ If the building proposed to be demolished has Water and/or Sewer service connections, and the building will not be rebuilt or replaced, said service connections must be permanently disconnected at the water and sewer mains. Any and all costs associated with service disconnections will be borne by the applicant. This work must be reviewed by the Water & Sewer Departments in accordance with established ordinances.
- ❖ I further certify that I will hold the Town of Whitefield harmless and indemnify the Town of Whitefield from any claims arising out of the demolition.
